A Plan to Lower the Barriers to Entry in Cycling within the NCNCA

In bike racing, the focus of attention is on the rider that wins the race, but the thrill of that win depends on the size of the peloton behind. The high barriers to entry inherent to bike racing limit the size of our peloton and make it much less accessible than other sports. Most races are expensive, located multiple hours driving distance away from population centers, and result in negative outcomes for beginners that dissuade them from racing again. These barriers are particularly exclusionary to women, minorities, and disadvantaged groups.

As a candidate for the NCNCA board I propose a few simple changes to how the NCNCA organizes, promotes, and supports bike racing in our district that would make bike racing cheaper to participate in, easier to access, and more engaging for participants and spectators. These changes include expanding and supporting weeknight practice races across the NCNCA to increase new rider skills prior to competing in sanctioned events, securing sponsors for the Best All-Around Rider and Best All-Around Team competitions to subsidize race entry fees for new racers, and developing new forms of engaging social media content to spotlight diverse racer's cycling journeys.

As a first year racer and in the NCNCA, full time Public Administration student, and the volunteer social media manager for the Monterey Bay Racing Team and Sand City Criterium, I am uniquely qualified to understand the barriers that exist to new racers, propose policy and operational changes that can effectively address them, and ensure that those changes result in the long term development cycling in Northern California and Northern Nevada.
