<u>Public Comments</u>: (Hunter Ziesing): Presentation of possible involvement by Hammer Nutrition in NCNCA programs. Sponsorship of a series? (Eric Salendar): Agenda published. Schedule discussion in Committee reports, later in meeting

President (Soto): Contacts with USAC. Master World CX Championships in January in San Jose has been cancelled. USAC should let NCNCA know directly when something like this is in the pipeline. Nevada State CX Championships: Mike Larsen did a good job. California CX Championships: SoCal: Some issues with junior championships rules/eligibility. Erin Hawley is the new Business person at USAC. New Races proposed for 2016: Dave Nelson -- Late season San Ramon Criterium; Dr Rogers: Annual Mt Diablo Challenge 1st weekend of October to include USAC event. Bike Reg Premier series sponsorship money has come in, and \$666.45 from regular Bike Reg sponsorship. 2016 Championship bids: So far 2 from Red Kite Racing, for Masters/Women/Junior Criterium, and Elite Criterium.

<u>Safety</u> (Soto): Committee preparing an addendum for the back of the usual release form, with check boxes and signature by rider informing them of important safety factors in cycling events. Possibly getting USAC to put this online with the license application? At officials meeting, on poster boards at race registration? New committee members: Phil Roberts and Rob VanHouweling.

<u>Competition</u> (Camacho): Working on Series and Points; Planning to add Master 55+ and Women 35+ to Premier Series. Discussing U23 category.

<u>Women</u> (Nielsen): Working on Series details. Looking for numbers. B4T9 \$\$ are in the bank and available to Women's Committee. Part for donations, part for 2016 proposal. **Proposal**: (Nielsen, DeFiebre) \$500 to be spent as per Women's Series winners direction: Mtn to Mtn organization, \$75; League of American Cyclists, \$75; Early Bird entries for new women, \$150; Davis Hall of Fame Installation, \$75 (food) \$125 (donation). **Approved** 7-0.
