Public Comments: Kennedy and Ebner: Comments for Junior proposal (3 items)

- 1) Update for Junior Tab on Website (currently has 2016 statement and etc). Clikc on tabs to find Junior races.
- 2) Juniors Emergency proposal rather than next month as Richie's proposal is very much the same as 2016
- 3) Competitive Series: Funding from other places than the Juniors budget. \$500 per race? \$5,000 budget. If money left over, go back and fill in.

Ebner: Have all the junior races on the site as a suggested list; select 5 or so to support more (eg: Bariani, Cherry Pie, Cat's Hill, Nevada City)

Rosefield: Cherry Pie, Cal Aggie, Cal Berkeley, Cat's Hill, NevadaCity, Snelling, Davis, Wente, Tour d Nez, Bariani, Dunnigan Hills, Memorial Day, Winters.

Kilun: Juniors series and money set aside to support junior races.

(Long Discussion).

Proposal (Jones, Rosefield): Support Junior races: Categories needed: 15-18 1/2/3, 15-18 4/5, 14 and Under, Jr Women. Includes 2017 road year past and forward: \$500 per race. \$5,000 in budget, more can be allocated; adjustments as needed. Past races to include Cal Aggie, Cherry Pie, Cal Berkeley, Snelling, LandPark/Bariani. **Approved**: 9-0. Jones to provide concrete proposal language.

Need to Reach out on email, Facebook, and Junior team list.

All races with Junior categories should be on Junior list on the website.

<u>President</u> (Camacho): Discussion: <u>Team Limitations</u> for % or riders in a race from one team. 10+ max? Promoter can make announcement. Forward ideas to Competition Committee? Promoter buy-in needed; teams buy-in needed. Kilun to discuss with Mike Sayers. <u>Assistance from moving vehicles</u> (drafting follow car to improve position - problem at Snelling and Chico): Burgess to note the rule prohibiting this to general public. <u>Mixing Women with Men</u>: Women pro riders can only ride in Women 1/2/Pro or Men 1/2/Pro. Other rules relating in rulebook.

Treasurer (Rosefield, Abt): 23015 taxes are filed, 2016 in progress. January reports completed, February in progress. Current bank statements in Dropbox.

Minutes: Jan Minutes to Alec; No February meeting was held.

DeFiebre: <u>Letter from Women's Committee</u> to Promoters list to hold 3 groups of Women at races: Women 1/2/3Pro; Women 3/4; Women 5 (or Women 3/4/5). **Approved** to send out 9-0.
