Public Comment: Duane Strawser, mayor of Nevada City and Tour of Nevada City organizer: Not enough women last year (only 4) and still want to be part of the Women's series, but how? Bundle a weekend with Tour de Nez if it can be exclusive, it will work.

<u>President</u>: (Camacho): Budget discussion. Local Pro Women can be part of the BAR/BAT program, but BAR/BAT excludes pro continental teams and World Pro Tour men. Pro racers only cannot be in Championships, except if separate pro race.

<u>Treasurer</u>: Kilun not present; Camacho says current expenses in 2017: \$76,295.30, income \$60,000.86. Currently in checking: \$19,704.02, savings \$65,352.03.

Committee Reports:

Officials (Burgess): Not much different than last report; \$2,500 expense for new printing stopwatches (\$1,200 coming back) fort extras purchased by officials. Still looking at different TT timing systems. Scheduling (Camacho): 96% of dates are validated; 113 races. 5 not validated.

<u>Safety</u> (Axell): AMV went to CPR – same machine good for safety. More info coming from Moor. <u>Women</u> (Moor): Coaches Q&A on Early Bird Team Day (Jan 21) during 1/2/3 race (3:30pm). Velo Promo to provide table and chairs. Series are coming together. Haley Nielson to follow up with Snelling Road Race to fit in with series.

Competition (Kilun- absent): Discussion of saving \$ with fewer trophies in series <u>Juniors</u> (Ebner): Series is coming together. Snelling and Copperopolis ok, as long as Junior 4/5 is included. Stipends from 2017 were for those races that had 14 & under, 15-18 1/2/3, 15-18 4/5. \$500 stipends are available for 2017 races that meet this. Contact Steve Rosefield.
