#### President:

With 22 events complete and 23 events to go we are at mid season. District Championships start in June with Regalado for Masters and Pescadero for Elites. It is exciting to have our first full year of racing back.

Reimbursements - Rider, Licenses and Shirts, Nothing unusual.

Mid-year review of budget vs. actuals.

\$43,000 in bank as of 1/1/2022

Projected loss in budget = \$12,000

Treasurers updated loss projection if all expenses in budget are paid out = \$16-17,000

Reason: overestimate of surcharge income and lost races of Sky Express

Race surcharge tracker, treasurer asked for ontheday.net access to get unique rider numbers, because it is difficult and time consuming to get that paper work from all but a few chief refs. Proposed contractor pay raises (Erik C. please add your proposed numbers)

- Will remove request
- We need a better process to receive NCNCA surcharges from race promoters.
  - Can race promoters send payment electronically? Possibly using Zelle?
    - Can consider using PayPal or Venmo.
    - Can also use for reimbursements
    - Rikke action item: Look into what's required to setup a business acct
      - Send some CRs a self address envelope for the surcharge check

## Competition:

### Membership:

45 members as of 5/3/2022, with "old" membership rates, that could have been \$3,225

2019 - 64 members, \$5,275 (\$75-\$125)

2020 - 48 members, \$5,250 (\$100-\$150)

2021 - 41 members, \$4,375 (\$125-\$150)

2022 - 45 members, \$9,150 (\$150-\$500)

27 past members were emailed on 4/21, only 2 renewed. Most of those teams are no longer active.

- Due diligence of where fees would best come from (or consider all)
  - Individual memberships

- NCNCA needs a 1 year plan and a +3-year strategic plan
  - Need to start this at the end of the current season so we can change things before the start of next season

### Women:

Summer series is in the works, despite endless social media "feedback".

A response was posted to suggest the following venues for providing constructive criticism:

- 1. Join a board meeting
- 2. Send a letter/email to the board
- 3. Ask women's committee lead (Rikke) to meet over coffee, and provide your feedback face to face, in person

Thread was shut down after different communication paths were encouraged, to minimize further hostile Facebook "discussion".

How to get better work with social media given that everyone is constantly criticized or attacked on social media?

## Note of public criticism of fields at Auburn:

If riders or board member have any concerns about field combinations at races, contact the promoter privately

Matt - Researched fields and put the fields together based upon recent racer demographic data, Take home message for all social media: contact the board, the promoter, or whomever **privately**, instead of criticizing the efforts of the board or of promoters on social media. We don't want racers to get discouraged from going to races due to social media negativity.

## Policies and Procedures: (Grefrath)

Code of Conduct. Thank you Rikke for providing updates! Briefly, would like to discuss and then vote on introducing the code of conduct into the bylaws. The code was taken from OBRA's code and establishes a standard of behavior, aligning with USAC, USADA, and SafeSport guidelines, as well as governmental laws governing illegal behavior. Intent on establishing this code is to set a standard to govern and sanction individuals in the event that they break areas of the code. Ultimate intention is to maintain civility, respect, lawful, and safe behavior in the NCNCA.

### DevelopmentMarketing/Comms: (Grefrath)

Group ride list: Suggest linking off the website to the group ride list provided by Megan Brinkmeyer and Haley. Disclaimer doesn't seem to be needed (there isn't one for Swamis: <a href="https://swamis.org/rides-events/weekly-group-rides-t/">https://swamis.org/rides-events/weekly-group-rides-t/</a>). Suggest promoting the list off the main website page as well as Facebook groups. Initially, the list should be organic, open for editing, so that the latest information can be added or deleted.

- 1023ez form Haley can take on in the next month or two.

USAC club survey: FYI - USAC conducted a survey of member clubs, inquiring about the need for more club support and communication. Survey seemed biased towards an expansion of services.. le..
