## Proposed 2011 Contracted Positions (Bill Nicely)

#### **Equipment Manager**

The Equipment Manager is responsible for the acquisition, maintenance and management of race equipment to include distribution of equipment to events permitted through USA Cycling by NCNCA. Maintains a current inventory of equipment and participates in making recommendations for equipment replacements and upgrades. Implements all applicable NCNCA Policies and Procedures. Assists in meeting the following USAC contractual requirement:

4.8 Provide or schedule race equipment where race equipment is available.

Current Compensation: 15,000 per year

### **Results Coordinator**

The Results Coordinator is responsible for all results management in NCNCA. Assists event directors/promoters in uploading results. Tallies and publishes results for NCNCA-sponsored points series and manages other points series as identified by the NCNCA BOD. Implements all applicable NCNCA Policies and Procedures. Assists in meeting the following USAC contractual requirement:

4.20 Assist USAC Results and Ranking Program by identifying BAR/BAT races within LA area including submittal of results. Current compensation: 4,000 per year

## **Permit Coordinator**

The Permit Coordinator is responsible for permitting events according to USA Cycling guidelines and NCNCA policies/procedures. Processes post-event paperwork to include electronic storage of documents and transmittal of forms and payments as appropriate. Actively manages same day license information to assist NCNCA marketing efforts. Implements all applicable NCNCA Policies and Procedures. Assists in meeting the following USAC contractual requirement:

- 4.3 Local race scheduling.
- 4.4 Review and submit in a timely manner all fully completed event permits to USA Cycling.
- 4.5 Review and submit in a timely manner all post-event paperwork.
- 4.6 Assist in recovery of outstanding and delinquent post events, including payments due USA Cycling.

Current compensation: Uncompensated (amount to be determined)

### **Officials Coordinator**

The Officials Coordinator is responsible for oversight of all NCNCA officiating programs. Coordinates the training, development and assessment of officials. Responsible for the assignment of officials for events in NCNCA. Serves as liaison with promoters, Chief Referees, and the NCNCA BOD. Serves as the district representative on the Regional Technical Commission which seeks to establish mentoring, evaluation, recognition and talent identification program. Responsible for ensuring that sufficient officials training clinics are held. Implements all applicable NCNCA Policies and Procedures. Assists in meeting the following USAC contractual requirement:

- 4.7 Assign qualified officials for all non-national championship events.
- 4.12 Support and facilitate USA Cycling Certification Programs.

Current compensation: Uncompensated (volunteer position)

# **Coaching Coordinator**

Implements all applicable NCNCA Policies and Procedures. Assists in meeting the following USAC contractual requirement:

4.12 Support and facilitate USA Cycling Certification Programs.

Current compensation: Uncompensated (volunteer position)

## **Upgrade Coordinator**

The Upgrade Coordinator is responsible for administering category upgrade and downgrade requests according to USAC guidelines and NCNCA policies/procedures. Implements all applicable NCNCA Policies and Procedures. Assists in meeting the following USAC contractual requirement:

- 4.9 Assist members with license upgrading.
- 4.10 Assist members with license downgrading.

Current compensation: 3,000 per year

# **Technology Coordinator**

Responsible for the implementation and management of the Chip Timing and other Results Management equipment (cameras, laptops, timers). Maintains an inventory of equipment and schedules the equipment for NCNCA events. Maintains a list of currently trained and approved equipment operators. Implements all applicable NCNCA Policies and Procedures. Current compensation: Uncompensated (amount to be determined)

## Webmaster

The Webmaster is responsible for administering all electronic delivery mechanisms in NCNCA to include websites, e-mail lists, forums and discussion groups. Provides support for all content providers and assists in training promoters and select users on the technical aspects of the electronic systems as needed/applicable. Insures that appropriate and approved standards are followed in content delivery. Implements all applicable NCNCA Policies and Procedures. Assists in meeting the following USAC contractual requirement:

4.11 Provide membership with communication forum such as website, newsletter, etc.

Current compensation: 3,000 per year

**Discussion:** Permit Coordinator: Who is watching for forms/payment for one-day licenses? NCNCA should be after these to convert to annuals. Perhaps capture electronic images of one-day forms for now, then later, do data entry. Perhaps name/email address only? Set compensation at \$3,000 annually.

Equipment Manager: Justification for \$15,000: 115 races, mostly for travel costs.

Officials Coordinator: What should compensation be? Does the position advance the coordinator's standing as an official nationally? Undecided

Championship Events

Phipps: Several Championships bids unopposed and *approved 9-0*: Sattley (Elite and Master TT); Dunlap (Junior TT); Panoche (Junior RR); Livermore (Junior Crit). Pescadero (Elite RR) was *approved 8-0-1abst* with some safety concerns; Oakland (Elite Crit) *approved 8-0-1abst*. No official bid was received for Master RR, and four bids were received for Master Crit: Central Calif Crit, Golden State, Joseph Mendez and Minden. Minden was voted out (8-1) due to incomplete bid. **Proposal**: Request more info from the other three before a decision later *approved 8-0-1abst* Chip Timing

# **Draft of Chip Timing Implementation plan (Hernandez):**

Marketing:

Possible means of information dissemination: NCNCA web site, email group, forum, and USAC mailing list. Provide complete information on chip timing implementation plan by Dec 20<sup>th</sup> to cover first two months of the racing calendar (three weeks before 1<sup>st</sup> Early Bird Training Criterium).

#### NCNCA policy for events utilizing Times7 chip timing:

- Events with Cat 5 men cannot be combined with other categories.
- No Chip No Result! Results will not be posted for racers who fail to finish their race with a timing chip properly mounted.
- Women Cat 4 with one-day license entry must rent or purchase timing chip. Day of race and on-line processes described below apply.

## Chip distribution:

Day-of race chip timing assignment:

Lookup racers in database, write name and license number on chip, scan chip, hand out chip. On-line chip ordering:

During on-line race registration, For NCNCA racers, Free with \$5.00 charge for shipping and handling (on-line chip ordering to end 7 days prior to race day). On-line process will allow racer to bypass race day chip assignment process. Out of district racers will be required to rent their timing chip and return the timing chip by the end of the day. Failure to return the timing chip will result in an additional credit card charge of \$30.00 for chip replacement.

#### **NCNCA** resident racers:

1st Chip Free

Replacement Chip \$30.00 (results will not be posted for entrants without a timing chip)

#### Non-NCNCA resident racers:

Chip Rental USAC license will be held for deposit, if chip is not returned at end of day, license suspension until the timing chip is returned? or \$30.00 chip replacement fee paid.

Chip Purchase \$30.00 (non-resident racers who frequently race in NCNCA events may find it

more convenient to purchase the own permanent chip.)

#### **NCNCA Residency:**

---Day-of race: USAC licenses that list "CALIFORNIA NCNCA" will determine NCNCA residency. USAC "Western Region" database download may also be used to determine current license and residency status. Racers with pending annual licenses receipts will have to rent their timing chip at each race until their permanent license is issued by USAC.

---On-line: USAC "Western Region" database download will be used to determine current license and residency status. Racers not listed in the database will have to rent their timing chip and will be required to return the timing chip by the end of the day. Failure to return the timing chip will result in an additional charge of \$30.00 for chip replacement.

## System use, staffing and results management fees post roll-out:

---Small event: One person to setup pre-race software, setup and train registration staff on timing chip distribution before start of race, setup and run finish line timing during race, generate race-day results, load results to USAC website and post-race results management. \$175 - \$200 plus \$.50/mile mileage

----Medium to large event: Two people to setup pre-race software, setup and train registration staff on timing chip distribution before start of race, setup and run finish line timing during race, generate race-day results, load results to USAC website and post-race results management. \$200 - \$225 each plus \$.50/mile mileage Roll-out events:

# **Proposal** for change in Premiere Series and BAR/BAT programs:

The top fifteen results from the 20 events would determine scoring for the three series podium positions. The winners of these four categories would be titled the "Best All Around Rider". These 20 events would include double points for the NCNCA Points Series.

The BAR/BAT program would be retitled "The NCNCA Points Series" with the same points calculations and prizes as in the 2010 BAR/BAT. Winners in each category would be designated the "NCNCA Points Series Winner" for both Team and Individual classifications.
