<u>President's Report</u> (Burgess): Thanks to Board for electing President. Local Association (LA) Summit Report: ON a slide show which is confidential to the Board until the USAC approves all announced changes. --Probable increases in license fees, one day fees, permit fees... --Members of the Board and all officials will have to undergo USAC Background check. --Continuing education for officials (webinar for Sports Officiating). Need to work on planning for next season.

<u>Treasurer's Report</u> (Rosefield): Quick Books on line for officers/BOD; it's a read-only program to give more info than available in the past.

Committee Reports:

Scheduling: (DeFiebre) 2014 schedule out to riders on the NCNCA Yahoo Group (reported by Burgess)

Officials: (Franklin) Free Classes for new officials (including Jan 27, 2014). Barry Orlando will be handling Officials' mentoring. Cameras discussed: Burgess will see if a demo of Finish Lynx is possible.

Championship: (Franklin)Requirements for Championships and Series (Points and Premiere) to be sent to Race Directors. For Premiere, (similar to Championships) these include podium, sound/announcer, results, call ups, etc. The Premiere Series will end with the Giro di SF? Discussions: Series redundancies; Championships to be part of Premiere Series? A paragraph is needed defining each series. Results need to get in to USAC by Wednesday following race. —A new person is needed to tabulate points for series (Ken Hernandez retiring) --Teams are responsible for riders being listed correctly as members of the team.

<u>Membership</u>: (Rosefield) Applications to go out via yahoo groups by December 1. (No change in \$50 club fee) – Promoters list, officials list, general list. Ned to be updating lists and contacts. Reiterate that points for series don't count until the club is a member (and only from that point on, not retroactively). <u>Promoters</u> (Rosefield) asked Race Directors what they are concerned about. Answers: Equipment, Who to start with first (City/County or USAC) re: permits. Who is the moderator of the Promoter's Yahoo Group? (Warren Geissert, TimBurgess, Robert Leibold?) Valecia Fraser is the USAC Member Services Rep for NorCal/Nevada.

<u>Policies and Procedures</u>: (Fisher): Has created a list of all passed and defeated Board proposals is now available. There is nothing in these records about how to handle Board mileage. Rosefield: Board members can submit mileage for Board business (primarily meetings) from October 2012 trhough September 2013, to get us up to date.
