<u>Protection for Early Birds Program</u> from other races: Discussion and then tabled 8-0-1 <u>USAC Local Association (LA) Conference</u> attendance: Rosefield and Burgess to represent the NCNCA. **Approved** 8-0-1.

# Official's Pay in NCNCA District:

**Proposed**: (Hardaway, DeFiebre) Official's Fees for NCNCA for 2015 for a full day of 5 or more hours shall be 150% of the USAC fees (as set for 2014). For racing days of less than five hours, the rate shall be 200% of the USAC half day rate. Mileage shall be the prevailing IRS business rate. Per diem expenses shall remain the same as current USAC expenses. **Approved** 8-0-1.
