Called to Order: 7:35 pm

**President (Kerrigan):** License and rider numbers ahead of last year. (Licenses 200+ as of now). Currently 4,174 domestic licenses, 264 international for NorCal/ Nevada. Motion to move Scheduling meeting to October for earlier planning (Leibold) withdrawn. Motion to add elections to Scheduling meeting, or to perhaps do elections online - the track association does that (Lown - and will talk to Fu about overseeing such a project) Hamilton will look into sites for scheduling meeting, which will be November 2 in the East Bay.

**Vice President (Meilahn):** 4 NCNCA juniors qualified at the district track championships for the Nationals. Complaints about results: Which chip system will we buy? Winning Time, Championship, or Hard Card? (plus a new entry on the scene: www.Times-7sport.com).

Concerns: system cost, rider cost, workability, staff requirements. Plan: Put together a working group of 3-5 people (with at least one rider, one official, one promoter) to produce a request for information/proposal to the four timing companies. The membership to be contacted to ask for members of the Working Group. (who to head?) Problem: Rider on track upgraded by USAC, not by local track committee or by local association (NCNCA). Proposal: (Kerrigan): NCNCA Propose in annual contract with USAC that all upgrades up to Cat 2 de done by Local associations, not coaches or USAC staff. Kerrigan to prepare wording for change; Leibold and others to present at Local Associations meeting in Colorado Springs in November.

**BAR/BAT (Ken Hernandez):** Caught up to Sept 7 (except for Clovis & Folsom).85 races in the system; Still to go: Henleyville, Chico and Everest. 8,730 entries in the database; 1,757 different licensed participants.

Treasurer's Report (Lown): Financials supplied (see report)

**Secretary (Leibold):** August minutes approved as provided/e-mailed.

**Equipment (Leibold):** "new" Laptop (#3) coming with a hard case to protect it. Ryan Fu says we should take a look at the Apple batteries and camera batteries for better performance in future. No discussion on traffic equipment/trailer.
